




Reviewer I

Thank you for submitting your work to the Journal Ners,

Your topic is relevant and timely. However I found some critical flaws and inconsistencies in your study that may affect your results. My comments are as follows: Title and abstract: Your title is about the psychosocial aspect, while in the abstract is about psychological aspect. These two terms are different, please adjust.

Introduction

First para. In the second sentence, what "this" refers to? Explain your statement in the third sentence, and add references, how stress and anxiety in parents affect children.

Method

Elaborate more in the method section, what are your dependent and dependent variables? how you select your sample from the population? What inclusion and exclusion criteria? How you developed your instrument? which theoretical framework or previous study that you used as the basis to build your current research questions.

Results

In table 1, what do you mean by confidence? Why put information source? Don't you think that they may receive information from more than one sources?

Table 2. How do you rate or classify the participant answer I these two variables? Please explain in the method.

You also mention about social response, please elaborate more about this variable in the method, and add a brief description in the introduction.

The table 3 presents 2 variables with categories that not fully corresponds with the categories presented in Table 1. Please revise.

It is confusing that your study variable of parent status reveal that 4 people are not parent. On the other hand, in the method section you mention that your sampling population are parents.

Discussion

My general suggestion for this part is that you must discuss your result referring to what previous studies found whether supports or not to your results and perhaps some theoretical grounds that might be in line with your results. I would provide specific comment on discussion only after the correct results are presented.

Overall, I suggest you to look again at the study variables and reanalyze to improve the quality of the study and the manuscript.
